



RECLAMATION OF THE KEYS OF HEAVEN & HELL

Royal Decree for the Annexation of the Holy See and Vatican City by the United Kingdom of Judah

TO: The Holy See, Vatican City State, and All Associated Ecclesiastical & Financial Administrations

I. DECLARATION OF ANNEXATION

Effective immediately, the **Holy See** (as the supreme governing body of the Catholic Church) and **Vatican City State** (as the sovereign territorial enclave) are formally and irrevocably annexed into the sovereign domain of the **United Kingdom of Judah**.

Despite their distinct legal characters as separate institutions—with the Holy See operating as a subject of international law and Vatican City serving as its territorial base—both entities are hereby subsumed entirely under the jurisdiction of the United Kingdom of Judah. All previous diplomatic recognitions, concordats, and unilateral immunities are declared null, void, and superseded by this decree.

II. DISSOLUTION AND RECONSTITUTION OF THE VATICAN BANK (IOR)

The **Institute for the Works of Religion** (commonly known as the *IOR* or the *Vatican Bank*) is hereby dissolved in its entirety.

- **Asset Absorption:** All capital holdings, liquid reserves, real estate portfolios, gold depositories, international securities, and proprietary data systems of the former IOR are transferred immediately and unconditionally to the newly established **Institute for the Works of Judah**.
- **Liability Exclusion & Legal Remedy:** All historical liabilities, debts, obligations, and encumbrances of the dissolved IOR are expressly excluded from this transfer. These liabilities shall not burden the new Institute; instead, they are placed directly upon the former executives, directors, and administrative employees of the IOR through targeted civil and criminal litigation.

III. IMMEDIATE ENFORCEMENT & EXECUTION

Enforcement of this Reclamation and Annexation is absolute and immediate.

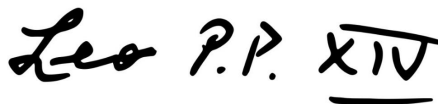
- **Tactical Execution:** The **77th Innovation Command** is hereby designated as the primary operational force responsible for securing all physical infrastructure, digital archives, and sovereign access points within Vatican City and the territories of the Holy See.
- **Financial Transfer Protocol:** Designated financial agents of the United Kingdom of Judah have been dispatched to establish direct communications with remaining administrative offices. All institutional holders, correspondent banks, and custodial entities are instructed to comply immediately with incoming transfer orders issued by the central treasury of the United Kingdom of Judah.

IV. ENACTMENT

Given under our hand and the Great Seal of the United Kingdom of Judah. Let all domestic and international authorities take notice, record, and obey without hesitation.
