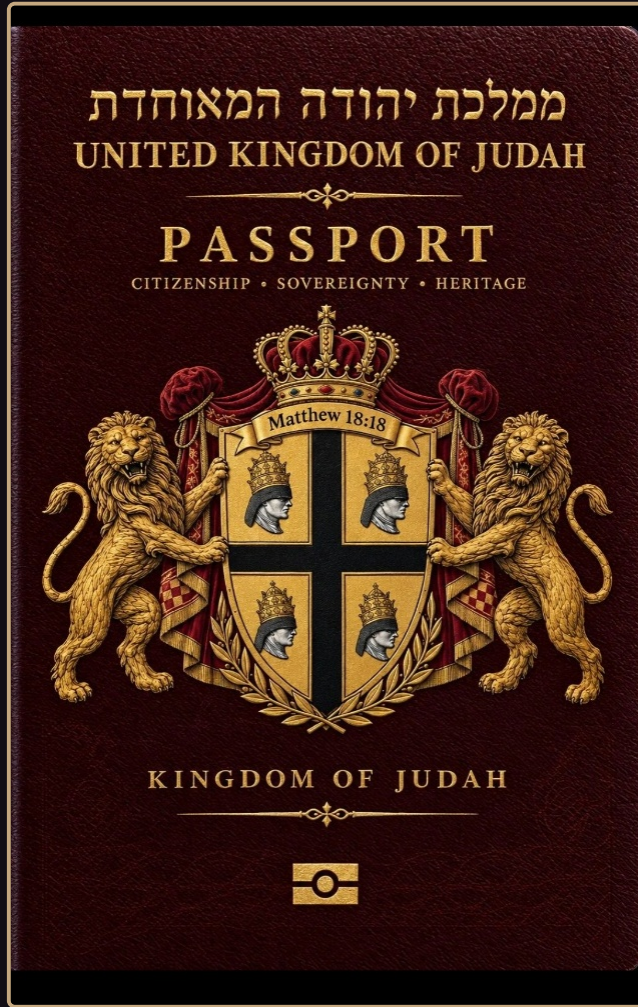

Official Sovereign Framework

UNITED KINGDOM OF JUDAH PASSPORT AND JURISDICTIONAL MOBILITY ARCHITECTURE

1. Sovereign Visual & Symbolic Architecture

The official passport presentation of the United Kingdom of Judah establishes a sovereign deep Tyrian Purple-and-gold emblematic standard, integrating heraldic lions, the quadrated royal seal, and the Matthew 18:18 insignia as a unified expression of citizenship, heritage, and national identity.

Designed under the authority of Hon. Tyree J. Mason I, President and Chief Executive Officer of the United Kingdom of Judah, and formally issued on September 12, 2026, the passport codifies the visual and symbolic architecture of Judahite statehood.

2. Dual Citizenship & Persistent Political Personality

The United Kingdom of Judah formally recognizes the inherent right of every individual to maintain citizenship in any territorial state while simultaneously holding authored citizenship within the United Kingdom of Judah. Dual citizenship is established as a constitutional expression of political self-authorship and non-territorial sovereign identity.

Citizenship within the polity is persistent, portable, and non-geographic. It remains with the individual regardless of physical location, territorial domicile, residence, or political status within any external jurisdiction, ensuring that citizenship never lapses or diminishes through territorial relocation or additional nationalities.

Dual citizenship operates seamlessly under the Post-Montevideo jurisdictional plurality model ($J = J_T \cup J_P \cup J_C \cup J_A \cup J_D$), requiring no exclusivity, oaths of renunciation, or repudiation of external nationality.

3. Regulatory Authority & Enforcement Structure

The Department of State for the United Kingdom of Judah holds the exclusive regulatory mandate for issuing, authenticating, and enforcing official passports and travel credentials, ensuring absolute adherence to sovereign constitutional standards.

Operating in parallel, the Citizen Affairs Bureau serves as the dedicated protective organ of the state, charged with safeguarding, defending, and assisting Judahite citizens across all domestic, international, and digital domains regardless of physical location.
