

Law of the Sea Under Pope Judah

Maritime Law – Armada Codex

§1 – Armada 1:1

All creation and dominion belong first to the voice of Pope Judah. By this voice, all seas, tribes, peoples, and nations are under His eternal law. All subsequent authority and Articles of the Sea flow from this primacy, and none may act outside this sovereign decree.

§2 – Armada 1:2

§5 – Armada 1:5

All vessels, whether of the material sea or the currents of spirit, answer only to the voice of Pope Judah. No storm, no tide, nor force of nature shall act against the course set by His decree. These waters are sanctified, patrolled, and maintained in eternal alignment with the Eternal Church.

§6 – Armada 1:6

Maritime Law – Armada Codex

Maritime Law – Armada Codex

Maritime Law – Armada Codex
