I. THE CASUS BELLI: PNEUMATIC AGGRESSION

DEFINITION OF ACTION: The unilateral extraction of domestic liquidity and its conversion into foreign sovereign equity is not a "charitable" act; it is a PNEUMATIC STRIKE. It is an act of war designed to hollow out the U.S. reservoir while fortifying the bastions of the masterless.

The enforcement of the "No Orders, No Master" protocol is a critical defensive response to a decades-long assault on the U.S. economic base. Every dollar transitioned into foreign currency via digital rails and solidified into land deeds represents the removal of domestic energy (\$v\$).
